APPROVAL OF THE AGENDA

1. Commissioners approved the agenda for the meeting with the addition of several items under Other Business.

BRING-FORWARD SYSTEM

2. Commissioners reviewed the list of communications between the Commission and the governments that are awaiting responses.

ACTION ITEMS LIST, COMMUNICATIONS ACTIVITIES LIST, AND COORDINATED SCHEDULE

3. Commissioners reviewed the updated Action Item List, communications activities List, and Coordinated Schedule and received an update on the activities of the IJC geospatial team.

IJC RETREAT

4. Commissioners discussed the possibility of holding a retreat in late June but agreed that due to other priorities they would put plans for a retreat on hold for the time being.

MODERNIZATION OF THE IJC WEBSITE

5. Commissioners received an update on the web modernization project with a focus on the process to evaluate vendor proposals and noted that staff anticipates having a contract in place in June.

IM/IT

6. The IM/IT team and a U.S. section contractor outlined recommended amendments to the IM IT plan and discussed challenges faced by the Commission in meeting its IM/IT needs. Commissioners discussed IM/IT staffing and management issues and agreed that the Chair of the IM/IT working group should regularly inform the office managers of progress achieved and of any related concerns.

RECORDS MANAGEMENT

7. Commissioners received an update on the Records Management Project, including work plan revisions needed due to delays encountered. Commissioners noted that the team is developing a Joint Records Management Policy for consideration at the June Executive meeting.

INTERNATIONAL WATERSHEDS INITIATIVE (IWI)

8. Commissioners received an update on the ongoing and planned IWI projects and noted the increase in number and quality of projects submitted by boards. Commissioners also received an update on the status of the Climate Change Guidance Framework and its pilot project being carried out with the International St. Croix River Watershed Board.

IJC DATA POLICY

9. Commissioners expressed their support for the development of an IJC Data Policy and encouraged staff to have a draft ready for review at the June Executive meeting.

RAINY-NAMAKAN LAKES RULE CURVES REVIEW

10. Commissioners received an update on the activities of the Rainy Rule Curve Review Study Board and noted that the study board's final report has been posted for a 30 day public comment period. The Commission will be holding public hearings in the basin in August 2017.

LAKE OF THE WOODS WATER QUALITY

11. Commissioners received an update on the governments planned binational science activities in the Lake of the Woods basin, discussed board and staff comments on the proposed binational governance approach and requested to be kept regularly informed of any progress on this file.

GREAT LAKES TRIENNIAL ASSESSMENT OF PROGRESS REPORT

12. A. Communications Report on TAP Public Meetings

Commissioners received an initial overview of public comments received during the six public meetings and via the IJC website during the public comment period.

B. Triennial Assessment of Progress Report

Commissioners discussed a number of issues relating to the work plan and timeline for revising the draft TAP report on which both public and Great Lakes Advisory boards have provided comments. As a number of issues are still under discussion, Commissioners have called for a dedicated TAP call prior to the June Executive meeting. Commissioners did not on a timeline for completion of the final report but did instruct staff to work as quickly as possible to address work items outlined in Options 1 and 2 of the briefing note.

PHRAGMITES

13. Commissioners requested that staff provide them with recommendations on a potential role for the Commission regarding the Phragmites issue at the June Executive meeting.

GREAT LAKES EXECUTIVE COMMITTEE

14. Commissioners discussed the desired outcomes of the informal lunch with the GLEC cochairs and discussed the key issues to be raised with them.

OTHER BUSINESS

15. A. Shoal Lake

Commissioners requested that staff prepare, for their review, a response to the March 8, 2017, letter from Chief Lewis of the Iskatewizaagegan No. 39 Independent First Nation and also prepare to transmit Chief Lewis' letter to governments reiterating the Commission's request voiced to governments in the Commission's November 3, 2014 letter.

B. St. Clair River

Commissioners discussed work to be undertaken by the US Army Corps of Engineers, and they invited the Canadian Chair to provide additional information.

C. Lake Ontario - St Lawrence River Water Levels

Commissioners received a technical briefing on the current flooding conditions in Lake Ontario and the St Lawrence River and agreed that a similar briefing should be provided to governments at the May 5th meeting.

D. Staff Recognition Program

Commissioners approved in principle the development of a commission wide staff recognition program and requested that Secretaries and the GLRO Office director draft a Policy, including criteria for a two tiered recognition program for their consideration.

E. Commission support for Boards

Commissioners deferred discussion of this item until US Section complete their needs assessment.

DECISIONS TAKEN VIA POLLING

International Rainy-Lake of the Woods Watershed Board

On April 27, 2017, Commissioners approved the appointments of Ms. Teika Newton and Chief Brian Perrault to be Canadian members of the board, and Mr. Lucas King to be an alternate member of the board for Chief Perrault, each for a three-year term, effective from May 1, 2017, to April 30, 2020.

Lake Superior Lakewide Action and Management Plan (LAMP)

On April 27, 2017, Commissioners approved for transmittal to the governments commission advice and recommendations on the governments' Lake Superior Lakewide Action and Management Plan.

International Lake Champlain-Richelieu River Study Board

On April 21, 2017, Commissioners approved the appointment of Mr. Louis Porter to be a U.S. member of the study board for a term effective from April 11, 2017, through the completion of the study.

International Lake Superior Board of Control

On April 13, 2017, Commissioners approved the International Lake Superior Board of Control's request that it be authorized to implement deviations from Plan 2012 flows during the period April to November 2017.

Great Lakes and St. Lawrence Cities Initiative

On April 13, 2017, Commissioners approved, as modified, a reply to a letter from chair of the Great Lakes and St. Lawrence Cities Initiative requesting information on implementation of Lake Ontario-St. Lawrence River Plan 2014.

International Lake Ontario-St. Lawrence River Board

On April 5, 2017, Commissioners approved a letter to the ILOSRB requesting information on the board's implementation of Plan 2014.

Great Lakes-St. Lawrence River Adaptive Management Committee

On March 30, 2017, Commissioners approved the appointment of Mr. Arun Heer to be the U.S. co-chair of the GLAM Committee for a three-year term effective from March 1, 2017, to February 29, 2020.

February 2017 Executive Meeting Minutes

On March 27, 2017, Commissioners approved, as amended, the minutes of the February 27-28, 2017, executive meeting.

Water Quality Board

On March 7, 2017, Commissioners approved the appointment of Ms. Tinka Hyde to be a U.S. member of the board for a three-year term effective from March 1, 2017, to February 29, 2020.

BOARD APPEARING ON TUESDAY, MAY 2, 2017

LAKE CHAMPLAIN-RICHELIEU RIVER STUDY BOARD

16. Commissioners received a status report from the study board co-chairs on the activities of the study board, including the establishment of the board, the public advisory group, and the IM/IT working group; development of the governance structure; timeline for key milestones including the development of the required work plan; and public meetings during the summer, The study board co-chairs also discussed a number of issues facing the Board, including funding uncertainties and the need for targeted Commission outreach to regional authorities.

BOARDS APPEARING ON WEDNESDAY, MAY 3, 2017

INTERNATIONAL LAKE ONTARIO ST. LAWRENCE RIVER BOARD OF CONTROL

17. Commissioners received an update from the board on high water conditions in the Lake Ontario-St. Lawrence River basin. The board briefed Commissioners about its experience to date with implementation of Plan 2014 and on its public outreach efforts. The Board noted that the recent high levels on Lake Ontario and the St. Lawrence River were caused by hydrologic conditions rather than the new regulation plan.

INTERNATIONAL NIAGARA BOARD OF CONTROL

18. Commissioners received an update from the Board on conditions in Lake Erie and the Niagara River and the falls. Commissioners noted that the start of the Lake Erie ice boom removal had been early due to unseasonably warm temperatures in January and February. Commissioners encouraged the board in its efforts to schedule public outreach events in the fall 0f 2017.

INTERNATIONAL LAKE SUPERIOR BOARD OF CONTROL

19. Commissioners received an update from the Board on conditions in Lake Superior and Lake Michigan-Huron. They noted that Lake Michigan-Huron water levels and outflows from Lake Superior were above average. Commissioners thanked the board for anticipating the need for deviations to reduce the impact of hydropower maintenance on flows in the St. Marys Rapids.

GREAT LAKES ADAPTIVE MANAGEMENT COMMITTEE

20. Commissioners received a presentation on the GLAM Committee's ongoing studies, public outreach plans and anticipated funding challenges. The Commission thanked the committee for its first Triennial Progress Report, which will be made public.

INTERNATIONAL RED RIVER BOARD

21. Commissioners thanked the board for receipt of its semi-annual status report and for its report on flooding conditions across the basin to date in 2017. Summaries of recently completed and proposed projects were discussed with Commissioners, including ones on fish migration in the Red River, implementation of IJC recommendations stemming from the 1997 Red River flood, and ongoing efforts to address water quality concerns.

INTERNATIONAL SOURIS RIVER BOARD

22. Commissioners thanked the board for providing an update on 2017 flood conditions in the basin including reservoir operation activities. Summaries of ongoing Souris Plan of Study efforts and related basin studies were discussed with Commissioners who encouraged the board to investigate and address water quality issues in the basin and continue to expand its communications and outreach efforts.

INTERNATIONAL RAINY-LAKE OF THE WOODS WATERSHED BOARD

23. Commissioners received an update from the Board on flows and water level conditions in the Basin and thanked the board for their recent correspondence summarizing their views on the binational water quality science plan presented by governments. The board also outlined how its Water Levels Committee has been working with the Rainy-Namakan Rule Curves Study Board to assess the potential implications of adaptive management and flood forecasting related recommendations. Commissioners noted that the commission would continue the shared funding arrangement for the Wheeler's Point Gauge.

INTERNATIONAL RAINY-NAMAKAN LAKES RULE CURVES STUDY BOARD

24. Commissioners received a summary from the study board co-chairs on progress to date on the review of the rule curves, including the release on April 27, 2017 of its draft report for public comment. Commissioners thanked the board for its hard work of the last two years, commending the board for its effectiveness and for the excellent outreach and transparency with which they have conducted their work. Commissioners agreed to be available the week of August 14 to 19 for the commission's public hearing, assuming all the materials needed for the hearings will be ready. Commissioners signaled their intent to attend the board's public meetings also scheduled that week.

BOARDS APPEARING ON THURSDAY, MAY 4, 2017

GREAT LAKES WATER QUALITY BOARD

25. Commissioners received an update from the board co-chairs on the implementation of the board's work plan. The Commission thanked the board for all of its work, in particular its extensive comments on the draft Triennial Assessment of Progress Report. The board co-chairs discussed the recently developed Great Lakes Water Quality Board Indigenous Peoples Engagement Principles and Practices and shared the document with Commissioners. Commissioners noted that they looked forward to receiving advice from the board on how the TAP process might be improved in future reporting cycles.

HEALTH PROFESSIONALS ADVISORY BOARD

26. Commissioners received an update from the board co-chairs on the board's ongoing activities, including the Acute Gastrointestinal Illness project, the Human health effects of Selenium report, and the results of its strategic planning process currently underway. Commissioners encouraged the board to carry on with its future project planning and scoping and to bring forward a recommendation to the commission on whether or not to move forward with phase two of the AGI project after the board receives the results of the phase one feasibility study at the end of July.

GREAT LAKES SCIENCE ADVISORY BOARD - RESEARCH COORDINATION COMMITTEE

27. Commissioner received an update on all the RCC projects; including: the improved research inventory for the Great Lakes region; and the modeling projects for integrated surface water and ground water and for nutrient adaptive management. Commissioners noted that when the research inventory is completed it should be accessible from the IJC web site and that they look forward to seeing the models. Commissioners noted that the RCC is a very productive committee, and they thanked the committee for its accomplishments.

GREAT LAKES SCIENCE ADVISORY BOARD - SCIENCE PRIORITY COMMITTEE

28. Commissioner received an update on all the SPC projects, including those projects dealing with: Information Coordination and Flow; Fertilizer Application; Potential Impacts from Petroleum Transport; Declining Offshore Lake Productivity; and the Great Lakes Early Warning System. Commissioners thanked the board for its work.

INTERNATIONAL ST. CROIX RIVER WATERSHED BOARD

29. Commissioners thanked the board for its annual report and expressed their support for ongoing efforts by the board to address issues surrounding the restoration of alewife to the system. Commissioners encouraged the board to continue its dialogue with First Nations and Tribes in the watershed to maintain constructive engagement. The board discussed with Commissioners the application by Woodland Pulp to surrender its Federal Energy Regulatory Commission license for the uppermost dam in the watershed, the Forest City dam at East Grand Lake, which is subject to an IJC Order of Approval.

INTERNATIONAL KOOTENAY LAKE BOARD OF CONTROL

30. Commissioners received an overview of conditions in the basin from the board co-chairs and noted the board's determination of the 2017 Spring Rise. The board reported that the FortisBC operated the Corra Linn dam in 2016 consistent with the 1938 Order. The board provided details of the work to rehabilitate the Corra Linn dam spillways, which is anticipated to be conducted from 2018 to 2021.

INTERNATIONAL OSOYOOS LAKE BOARD OF CONTROL

31. Commissioners received an overview of hydrologic conditions in the basin from the board co-chairs and an update on the board's activities, including in particular: the board's interest in participating in the Climate Change Guidance Framework pilot; and its ongoing documentary work to explain water management issues and practices in the Okanagan-Okanagan River system.

INTERNATIONAL COLUMBIA RIVER BOARD OF CONTROL

32. Commissioners received an update on the board's 2016 monitoring of the water levels of the Columbia River at the international boundary. The board outlined the backwater surface elevation changes at the International Boundary and noted that levels were in compliance with the IJC Order of Approval.

ACCREDITED OFFICERS OF THE ST. MARY AND MILK RIVERS

33. Commissioners received an overview of conditions in the St. Mary and Milk Rivers and of the activities of the Accredited Officers and Field Representatives and noted the A.O.'s and field reps active involvement in a number of IWI initiatives. Commissioners requested that staff draft a letter to inquire on the progress of the Montana Alberta Water Management Initiative.
